**Sub : COVID-19 vaccination drive (dose 1) for RRCAT  
CHSS beneficiaries at RRCAT Colony - regarding.**

Reference is invited to this Section Circular of even No. 392 dated 19.03.202, 413-417 dated 26.03.2021, 449-452 dated 05.04.2021, 453 dated 06.04.2021 and 454-458 dated 07.04.2021 on the above subject.

2. All employees of RRCAT are informed that COVID-19 vaccination drive (dose 1) has been arranged by the District Administration from **24.05.2021 onwards** near Security Main Gate, RRCAT Colony, Indore with the assistance of this Centre. During the drive being conducted by the District Administration, **the eligible CHSS beneficiaries** residing in/outside RRCAT Colony will also be vaccinated as per the availability of the vaccines. The vaccination on **24.05.2021** will commence at around **1000 hrs.** However, only **50 (fifty)** CHSS beneficiaries particularly RRCAT employees performing essential duties viz. staff working in security (10 nos.), fire & safety (10 nos.), C&S Division (10 nos.), Computer Division (07 nos.) and all drivers will be administered vaccine followed by other remaining CHSS beneficiaries on next scheduled dates after all the essential duty staff are vaccinated fully. The date, time and schedule of vaccination will be notified from time to time subject to availability of vaccine. The priority group will cover the beneficiaries who have missed their already confirmed vaccination slots due to restrictions imposed by the District Administration in movement of residents outside RRCAT Colony.

3. The beneficiaries may, therefore, avail the vaccination facility accordingly. They are advised to register themselves on COWIN website at [www.cowin.gov.in](http://www.cowin.gov.in) or ArogyaSetu App before visiting Vaccination Centre. They may also note that while visiting for vaccination, they must carry with them (i) Aadhar Card, (ii) CHSS Registration Card, and (iii) proof having registered for the vaccination on the above Website/App, which will be verified at the Registration Counter at Vaccination Centre and token no. will be issued to the beneficiaries accordingly on **"first come first serve"** basis.

4. General instructions/guidelines for vaccination for the CHSS beneficiaries are enclosed as Annexure-1. All CHSS beneficiaries are requested to strictly follow these instructions/guidelines before/during/after vaccination. They may note that vaccination will be done strictly as per directives/guidelines issued by Government from time to time. Hence, they are advised not to approach RRCAT Medical Centre unless required on account of pre and post vaccination complications.

5. The beneficiaries may also note that the vaccination drive is conducted as a welfare measure to contain spread of COVID-19 infection. As such, RRCAT Administration will not be held responsible for any unpleasant / unexpected incidents arising on account of COVID-19 vaccination. However, a team of Medical Officer/Para Medical Staff will be available at RMC during the vaccination campaign to attend any medical emergency.

**INSTRUCTIONS /GUIDELINES FOR CHSS BENEFICIARIES FOR  
VACCINATION AT RRCAT, INDORE**

1. This vaccination drive is conducted exclusively for eligible CHSS beneficiaries registered at RRCAT, Indore who are yet to receive their first dose of vaccination.
2. The beneficiaries are advised to follow all COVID-19 related protocols viz. maintaining social distancing, sanitisation and wearing of face mask properly.
3. Only the beneficiary who is to be vaccinated shall be allowed to enter the Vaccination Centre. If the beneficiary needs assistance, one person may be allowed to accompany her/him.
4. After vaccination the beneficiaries are advised to wait for 30 minutes in the observation area for any inadvertent symptoms post vaccination. After completing observation time, vaccinated beneficiaries should immediately leave the vaccination centre on instructions from the vaccinating staff.
5. COVID positive patients and their primary contacts are advised to take vaccination in consultation with Medical Officers of RMC.
6. All beneficiaries visiting for vaccination should not come empty stomach. They are requested to bring their own drinking water.
7. Some common side effects viz. fever, bodyache, shivering, headache, joint pain, pain at the injected spot can be expected after vaccination which can be managed with adequate rest, ample water intake and only Paracetamol Tablets. As such, beneficiaries are advised not to take pain killers.

8. The beneficiaries who have any drug allergy or allergy of any kind should inform the same before getting the vaccine and will be vaccinated only after consultation with RMC Medical Officer.
9. The beneficiaries who are on any immunosuppressant and any anti-cancer therapy should contact RMC Medical Officers before getting themselves registered.
10. COVID-19 appropriate behaviour, namely wearing of face mask, social distancing and sanitising should continue even after completing two doses of vaccination.
11. All are requested to cooperate by following the guidelines and make this vaccination drive safe and successful.
