Sub : Quarantine facility at MACCC, Indore - regarding.

Reference is invited to letter of even No. 25.04.2021 regarding constitution of team-1 with Nodal Officer Shri Sanjay Chouksey to coordinate with SDM/concerned District Authority for admission of COVID-19 patients at Maa Ahilya Covid Care Centre, Indore for quarantine and further treatment.

2. The Collector and District Magistrate, Indore and Sub Divisional Magistrate, Rajendra Nagar/Rau visited RRCAT, Indore on 23.05.2021 and taken a serious note of the increasing number of corona positive cases in RRCAT Colony. He has directed that all the corona positive cases (mild symptoms and asymptomatic) in RRCAT Colony are required to be shifted to Maa Ahilya Covid Care Centre (MACCC), Khandwa Road, Indore mandatorily for quarantine and further treatment to contain spread of infection in the colony as recommended by the Incharge, RRCAT Centre.



The employees and their family members residing in RRCAT Colony are, therefore, required to take a note of the directions issued by the Collector and District Magistrate, Indore and abide by the same in letter and spirit so that spread of the infection may be prevented in the Colony. They may also

note that non-compliance of above directives and non-cooperation with the Rapid Response Team deputed by the Sub Divisional Magistrate for shifting of patients for quarantine and treatment to MACCC will render the residents concerned liable for prosecution under **Section 188 of IPC of Epidemic Diseases Act, 1897 and Disaster Management Act, 2005** as notified by the State Government/District Authorities from time to time.
