**INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR e-TENDERING**

**PART A: GUIDELINES FOR E-TENDERING :-**

The bidders are required to submit soft copies of their bids electronically on the CPP portal, using valid **class-III digital signature certificate**. The instructions given below are meant to assist the bidders in registering on the CPP portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP portal.

1.	<p><b>REGISTRATION :</b></p> <ol style="list-style-type: none"><li>1. Bidders are required to enroll on the e-procurement module of the Central procurement Portal (URL: <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>) by clicking on the link "Online bidder Enrolment" on the CPP portal which is free of charge.</li><li>2. As part of enrolment process, the bidders will be required to choose a unique username and assign a password for their account.</li><li>3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP portal.</li><li>4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usages) issued by any Certifying Authority recognized by CCA India (e.g. Sify, nCode, eMudhra etc.), with their profile.</li><li>5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC to others which may lead to misuse.</li><li>6. Bidder then, logs in to the site through the secured log-in by entering their user ID/pass word and the password of the DSC/e-Token.</li></ol>
2.	<p><b>SEARCHING FOR TENDER DOCUMENT:</b></p> <ol style="list-style-type: none"><li>1. There are various search options built in the CPP portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value etc. There is also an option of advanced search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP portal.</li><li>2. Once the bidders have selected the tenders they are interested in, they may download the required documents/tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP portal to intimate the bidders through SMS/e-mail in case there is any corrigendum issued to the tender document.</li><li>3. The bidders should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification/help from Help desk.</li></ol>
3.	<p><b>PREPARATION OF BIDS:</b></p> <ol style="list-style-type: none"><li>1. Bidders should note into account any corrigendum published on the tender document before submitting their bids.</li></ol>

2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note number of covers in which the bid documents have to be submitted, the number of documents – including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
3. Bidders, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF/XLS/RAR/DWF/JPG formats. Bid documents may be scanned with 100dpi with black and white option which helps in reducing size of the scanned document.
4. To avoid time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to be bidders. Bidders can use “My Space” or “Other Important Documents” area available to them to upload such documents. These documents may be directly submitted from the “My Space” area while submitting bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

**NOTE: My Document space is only a repository given to ease the uploading process. If bidder has uploaded his documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.**

**4. SUBMISSION OF BIDS :**

1. Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>.
2. Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission date & time. Bidder will be responsible for any delay due to other issues.
3. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
4. Bidder has to select the payment option as “offline” to pay the tender fee/EMD as applicable and enter details of the instrument.
5. Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission. Otherwise the uploaded bid will be rejected.
6. The agency shall download the pre bid clarification if any for the work and upload the same (scanned copy) duly signed and sealed. The revised documents if any, shall be uploaded in e-tender portal.
7. Bidders may please note the following also regarding taxes and other liabilities etc:
  - (i) This work comes under Works Contract. Taxes applicable for such contracts must therefore be included in the quoted rates.
  - (ii) The contractor should be registered as mandated in the law relevant to GST.
  - (iii) The Goods & Services Tax (GST) as applicable for “individual materials, equipments, tools Etc.” and “individual items as well as overall offer” need to be included in the quoted rates/tender offer. Department shall not entertain any claim pertaining to reimbursement of GST, WCT, Turnover tax, Income tax, Corporation tax, Labour cess and all other taxes etc. lawfully paid by the contractor.
  - (iv) Labour Welfare Cess @ 1 % of gross value of work done shall be deducted from each running bill & final bill.
  - (v) Applicable, income tax/corporation tax, cess, TDS on GST, security deposit etc. shall be deducted from each running bill & final bill.
  - (vi) The bidder must possess valid EPF & ESIC registration. The reimbursement for EPF & ESIC deposit shall not be made.
  - (vii) The payment of wages to laborers should be made through bank.
  - (viii) In case the exchange of the obsolete item call for payment of any statutory levies such as GST/CD/Cess etc., all such levies shall be borne by the supplier/contractor concerned.(Undertaking as per Annexure-C of special condition)
8. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the

bidders. Bidders are required to download the BOQ file, open it and complete the SKY BLUE colored (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the file name. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

9. In this tender an item is "for supply installation, testing and commissioning of new Split air conditioners against the buyback of air conditioners (operated for more than 10 years) as is where basis, mentioned in technical specification of this tender .
10. Makes, model and location of AC's is given in technical specification of this tender and contractor can visit the site before submitting of offer.
11. Transportation of buy back items from RRCAT premises shall be arranged by the contractor itself without any extra cost.
12. The contractor will be entirely responsible for the safe disposal of old items without affecting the environment in any manner as per prevailing statutory rules and Act/ law of the land.
13. Bidders are advised to upload their documents well in advance, avoid last minutes rush on the server or complications in uploading. CSD, RRCAT, in any case shall not be held responsible for any type of difficulties during uploading the documents including server and technical problems whatsoever.
14. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
15. The server time which is displayed on the bidder's dash board, will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time line during bid submission.
16. Submission of tender documents after due date & time (including extended period) shall not be permitted.
17. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized person until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields, is done. Any bid document that is uploaded to the server, is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to a symmetric encryption using buyers/bid opener's public key. Overall, the uploaded tender document become readable only after the tender opening by the authorized bid openers.
18. Upon the successful and timely submission of bids (i.e. after clicking "Freeze Bid Submission" in the portal) the portal will give a successful bid submission message and a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
19. The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.
20. Intending bidders are advised to visit this website regularly till closing date of submission to keep themselves updated as any change/modification in the tender will be intimated through website only by corrigendum/addendum/amendment.

6	The bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards cost of tender document and EMD in favour of "PAY AND ACCOUNTS OFFICER, RRCAT, INDORE.
7	<b>On opening date, the contractor can login and see the bid opening process.</b>
8	<b>Certificate of Financial Turn Over:</b> At the time of submission of bid, contractor may upload Undertaking/Certificate from CA mentioning Financial Turnover of last 3 years or for the period as specified in the bid document.
9	The Commercial bid is provided along with this tender document at <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a> . Bidders are advised to download this commercial bid as it is and quote their offer/rates in the permitted columns and upload the same in the commercial bid. Bidder shall not tamper/modify downloaded price bid template in any manner. In case if the same is found to be tempered/modified in any manner, tender will be completely rejected and tenderer will be debarred from doing business. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in GREEN colour. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". 10	Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
11	The Department reserves the right to accept / reject any prospective application without assigning any reason thereof.
12	Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them may be done through a Technical Evaluation Committee of experts, constituted by RRCAT. The performance report from the executing authority shall also be considered for shortlisting.
13	<b>IF ANY INFORMATION FURNISHED</b> by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in RRCAT.
14	<b>NO MODIFICATIONS IN THE TENDER SHALL BE ALLOWED AFTER OPENING OF PART 'A'.</b>
15	If any tenderer withdraws his tender within the validity period and before award of work whichever is earlier or make any modifications in terms and conditions of the tender which are not acceptable to the department, then the government shall without prejudice to any right or remedy, be at liberty to forfeit 50% (Fifty percent) of the earnest money absolutely. Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.
